Scope of Work for Bay Area Regional Transit Connections Map

The Alameda-Contra Costa Transit District is seeking to create a new map showing transit services that provide connections between regions in and around the San Francisco Bay Area. The map will be used to inform AC Transit riders of AC Transit's bus transit service, as well as the transit service of other public transit operators in the two counties.

The map shall be schematic, with clarity prioritized over strict adherence to geography. The map shall extend to Cloverdale and Gualala in the northwest, Santa Cruz in the south, and Sacramento and Stockton in the east. However, areas on the periphery shall be compressed and areas in the center may be expanded.

The focus of the map will be the cities and towns served by transit. Most cities and towns will be labeled. Regional rail and ferry systems should be shown with their stations marked, but not necessarily labeled. Bus lines and bus-only transit hubs of regional importance will also be shown. The ocean and San Francisco Bay shall be shown in a simplified manner; other geographic features may be omitted.

Individual route identifiers will not be used; each agency's service will be shown in the agency color used in the Bay Area Hub Signage Program and labeled with an abbreviation of the agency name. Each agency's service will be shown as a line, with thickness varying depending on frequency and span. The thickest line will be used for services that operate every day and have frequency of 15 minutes or better during peak commute periods. Services that operate infrequently and/or operate only during peak commute hours will have the thinnest lines.

The map should show regional rail and ferry systems, as well as key bus lines representing connections between cities and towns. A preliminary list of lines to be covered is included at the end of this document.

Colors and fonts shall be the ones developed for the Hub Signage Program.

Scale and Size

The map shall be scaled so that it is legible when printed on an 11 inch by 17-inch page.

Deliverable and timeline

The map shall be created in Adobe Illustrator format and be provided in original (editable) form. The map should be completed by June 30, 2020.

Intellectual Property

This map will be performed as a work for hire and all rights to the work shall vest in AC Transit.

Use of logo

The Contractor shall not use the District's logo or any other proprietary material without the prior written permission of the District. The Contractor shall provide a copy or copies of any such material to the Designated District Representative for review and approval."

Quality

It is understood that the best general practice shall be followed, and only materials and workmanship of the best standard quality shall be used. The District shall be the sole judge as to the comparative quality and suitability of alternative equipment, articles, material or process, and its decision shall be final.
