

ADDENDUM NO. 4 TO THE RFP #2020-1489

The Alameda-Contra Costa Transit District herewith issues this Addendum No. 4 to the above-referenced RFP. Except as modified below, all other terms and conditions remain in effect. Strikethrough text represents deletions from the original RFP, and ***bold/italicized/underlined text*** represent additions to original RFP text.

A. QUESTIONS AND CLARIFICATIONS**Question 13 in Addendum#3:**

What model or type of respirator does your operators use? Is it N95 or P100? Is it a half mask or full mask? SCBA or non-SCBA? Do your mechanics use respirators as well?

- *Response: Respirator fit test service will not be required under this RFP. This response supersedes the response provided in Addendum #3. Respirator fit test has been removed from the Scope of Work and Price Proposal Form. Please see attached.*

Question 14 in Addendum#3:

Per OSHA, as we were previously told, qualitative fit testing (QLFT) is sufficient. Does AC Transit require quantitative fit test as well? Currently, our clinic has been doing only qualitative fit test with 7 exercises, but we can most certainly add an additional grimace test where the worker smiles or frowns for 15 seconds. Would AC Transit consider dropping the quantitative test to save some money? Please let us know if QNDT is still required as we can have our nursing/ MA staff get certified.

Question 15 in Addendum#3:

Since respirator fit testing is required for your new hires, shouldn't they also have respirator physical that would include OSHA MEQ Parts A-B reviewed by a medical provider to clear them to wear a respirator? DOT Medical Exam does not include these OSHA MEQ.

Which mask types will the vendor need to keep in stock?

B. CHANGES TO THE CONTENT IN THE RFP**III. Scope of Work**

Vendor shall be able to administer a Physical Agility Test to identify whether or not an individual has the physical ability required to perform the position for which he or she is being considered. This test shall be administered after an offer of employment has been made, but before the candidate officially begins work in the capacity of his or her new position. The types of Physical Agility Testing are the Manual Lift Test, Pulmonary Function Test ~~and Respirator Fit Test.~~

A. AC TRANSIT PHYSICAL AGILITY TEST PROCEDURE AND CRITERIA**3. ~~Respirator Fit Test~~**

~~The respirator fit test will determine if a potential candidate can properly wear a respirator.~~

Completing the Test

~~A medical evaluation completed by a healthcare provider to determine if the prospective candidate can safely wear a respirator should be completed prior to performing a respirator fit test. If the prospective candidate is cleared to wear a respirator, they will go through the following fit tests:~~

A Qualitative Fit Test (QLFT)

~~The respirator user will perform seven exercises for one minute each:~~

- ~~• Normal breathing~~
- ~~• Deep breathing~~
- ~~• Moving head side to side~~
- ~~• Moving head up and down~~
- ~~• Bending over~~
- ~~• Talking~~
- ~~• Normal breathing again~~

~~If the candidate does not detect any odor or irritation during these exercises, the fit test is passed, and the candidate is safe to wear their respirator.~~

A Quantitative Fit Test (QNFT)

~~The respirator will perform the same seven (7) exercises as the qualitative test, with an additional grimace test where the worker smiles or frowns for fifteen (15) seconds.~~

~~The leakage measurement on the test, or the fit factor, determines whether the candidate is safe to use their respirator. A fit factor according to the current protocols for fit testing is needed for half-mask respirators, while a fit factor according to the current protocols for fit testing is needed for full face piece negative pressure respirators.~~

Criteria for Passing the Test

- ~~• Candidates **MUST** successfully pass the medical evaluation~~
- ~~• Candidate **MUST** pass qualitative fit test~~
- ~~• Candidate **MUST** pass quantitative fit test~~

~~Failure to pass all three criteria will result in disqualification from the remaining exam/hiring processes.~~
