Section III, subpart 5 "Additional Requirements" item A on page 11, is hereby amended to read as follows: The successful proposer shall present the findings and recommendations to relevant AC Transit staff and the Board of Directors (if requested) following the staff's review and approval of the reports. If recommendations are made in addition to the items specified in this document, the successful proposer shall implement items as agreed by both parties. The implementation of the recommendations may be required of the successful proposer. All documents will be in Microsoft Word format. Tasks 1-2 are expected to be completed within 6 months of the start of the resulting contract. Review and approval of the deliverables in Task 3 will be required by 12 months prior to following the execution of this contract.

## 4. Responses to Questions Submitted

**Question #1**: On page 11 of the solicitation under Section 5 - Additional Requirements, Bullet A, reads the following sentence.

"Tasks 1-2 are expected to be completed within 6 months of the start of the resulting contract. Review and approval of the deliverables in Task 3 will be required by 12 months prior to the execution of this contract." Can AC Transit please confirm that the timeline of the above statement is correct?

Answer to Question #1: The completion of tasks 1-2 are requested to be completed within 6 months of the contract execution. These tasks include review existing practices, review procedures, review HASTUS settings, review current scheduling department organizational structure and develop recommendations. Task 3 (Deliverables) will need to be delivered within 12 months of contract execution. A hypothetical timeline is presented below for clarification. Please incorporate this timeline, any costs associated with this timeline, and realistic boundaries to this timeline in preparation of your technical proposal and cost proposals.
